#### **User Instructions**

Do not allow more than one child at a time to use the trampoline.

Do not attempt somersaults.

Use under adult supervision.

Handle must be held at all times when using the trampoline.

#### **Care and Maintenance**

Wipe mat with damp cloth.

Inspect the trampoline before each use and replace defective parts.

Ensure that the screws are tight and there is no slack in the bungee cord.

For indoor and outdoor use - do not leave outdoors when not in use.

#### **Warnings**

Handle must be attached before use as detailed in the instructions.

**\*\*Under no circumstances must the trampoline be used without the handle attached.**

Place the trampoline on a level surface.

Maintain a clear space on all sides of the trampoline.

Use only in a well lit area.

2 x Steel Leg Supports at 8.0" & 2 x Steel Leg Supports at 7.0" (B)

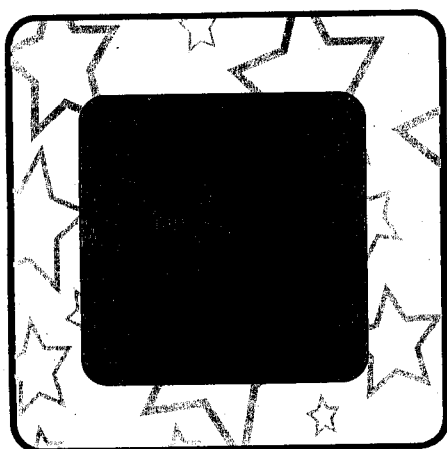
2 x Black locking screws used for the handle assemble (C)

1 x Steel Handle with Foam Support (D)

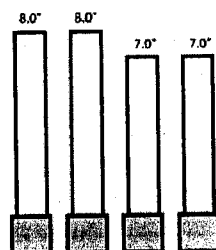

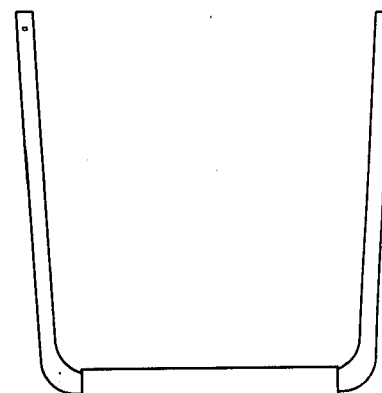

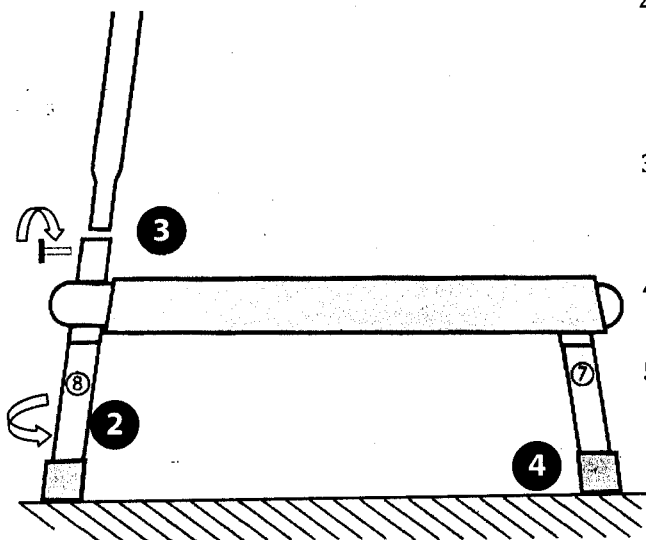

1. The Frame, Jumping Mat, Bungee and Safety Pad are pre-assembled.
2. Thread the 4 Steel Legs onto the base of the frame until tight. \*IMPORTANT: 8.0" legs go onto front of product and 7.0" legs go onto back of product, as shown. Note: 8.0" legs marked as (8) and 7.0" legs marked as (7).
3. Fit the Steel Handle with Foam support onto the frame with the bottom holes facing outside. Lock the frame into place by the 2 Black Locking Screws.
4. Adjust the rubber feet, so that they are in full contact and sit flat onto the ground.
5. To store the trampoline, unscrew the four Steel Legs and undo the Black Locking screws. Place the Steel Legs and Handle on top of trampoline and store the 2 Black Locking screws for safekeeping.



## **THE DO AND DO NOT'S**

**DO** supervise children at all times while they are using the product.

**DO** retain instructions with the product.

**DO** inspect product before each use.

**DO** instruct children on the proper use of product.

**DO** maintain 6 foot clearance all around the product.

**DO** require children to remove shoes before playing.

**DO** allow only 1 child at a time on the product.

**DO** keep pets away from the product.

**DO** instruct children not to attach items to the product that are not specifically designed for use with the equipment, such as but not limited to, jump ropes, clothesline, pet leashes, cables and chains as they may cause a strangulation hazard.

**DO NOT** allow children to lean over the edge of the product. Leaning over could result in tipping.

**DO NOT** place product near fire.

**DO NOT** allow children to jump onto or off of the product.

**DO NOT** allow children to use product who are unevenly matched in weight & height.

**DO NOT** allow other toys on the product.

**DO NOT** allow helmets, headgear, loose clothing, scarves, hoods, or clothing containing drawstrings when using this product.
